**Meeting called to order:** W. Vonada called the meeting to order at 6:59 p.m.

**Secretary Report:** T. Roberts read the Secretary Report as follows: T. Roberts submitted a grant application – AARP Community Challenge Grant Program in the amount of \$10,000.00 to help offset the cost of the tennis courts. We already received \$8,646.00 from the Clinton County Community Foundation Grant.

**Fire Report:** L. Rhine read the fire report for February 2024. The last breakfast will be on March 16<sup>th</sup>. There are currently 6 people going to the EMR class.

**Zoning Report:** T. Roberts read the Zoning Report as follows: Permit activity report from Code Inspections, Inc for January 2024. 16 Permits Issued: 2 Mechanical; 2 Building; 1 Violation; 1 Demolition; 2 Energy; 2 Plumbing; 2 Electrical; 4 Zoning.

**Public Works:** W. Vonada stated we have been putting up signs, replacing signs, they keep getting damaged and we don't know how. We are doing an inventory of signs; we have been warned by PennDOT that they can be inspected. We are recording the ones that are not up to spec. We are looking for grants to buy signs. We had talked about ordering raincoats last year, and we had got permission, but it was last year, and we found some on sale and they are like \$30.00.

- a. **Ridge Road** – The south end of Ridge Road, it's the portion that runs from Auction Road to Interstate 80, it's a dirt road. It hasn't been inspected since 1989 and we didn't know it was even a township road that far back. Someone bought a property back there and would now like to have a right of way on to a township road. We are getting a price on bringing it up to spec. It has been on liquid fuels the entire time. We did go in and mow it back a bit. We need to put just enough money into it to keep it on liquid fuels.
- b. **Equipment Rental for E. End Mountain Road.** – We need to clean the ditch out going up over East End Mountain Road the dirt road portion. The price to rent a machine, a mini excavator, is going to cost between \$350.00 to \$400.00 per day. We would be getting it at Duck Run. W. Vonada would like D. Chappell's input on it, because we need to do it soon, but since we would be spending money I would like everybody to be involved in that.

**New Business:**

- a. **PennDOT concrete patching** – PennDOT asked us to bring up a project they will do this summer at the Salona Intersection. They are going to be doing concrete work on both northbound on-ramps. They will have detours. They will be doing concrete work underneath the bridges on 220.
